

The Governing Bodies of both schools have been exploring forming a federation. They now know that this would not serve the best interests of our community.

A working party was set up to explore different multi academy trusts (MATs) to join. Research was undertaken by Governors from both schools. They approved a proposal for our schools to join the Mid Essex Anglican Academy Trust.

A key factor in this selection is because we know that it will not change the values and principles of our school. We will contribute to the expansion of the MAT and support it in its future growth.

The Mid Essex Anglican Academy Trust includes Shenfield St Mary's Church of England Primary School and Mountnessing Church of England Primary School. Bentley St Paul's Church of England (VA) Primary School are joining in September. The infant and junior schools have requested to join this Trust. It will be subject to approval by the Department for Education.

As a member of the Brentwood Collaborative Partnership we already work well together. We have engaged and developed joint activities. This has included moderating writing, early reading training, visiting schools and sharing resources.

There is a similar ethos and understanding between the member schools. Our school vision and values compliment those of the Trust. We want to ensure our finances for the future are stable. The member schools are near which is practical for working together. Engaging with this Trust will form a successful partnership for our community.

There are many positive benefits for all member schools and their pupils for being part of this MAT. It will provide opportunities for us all to live life in its fullness and unlock our potential. For example:

**Improved outcomes:** The member schools are successful. There will be opportunities for us all to develop our practice further. This will enhance the learning experience all our pupils receive as part of the Trust.

**Strengthen Leadership:** Leaders and teachers can share their combined expertise, knowledge and thinking. Increasing opportunities to work on challenges and solutions together. Building trust and learning from each other to benefit and connect us all within the Trust.
