About this form

All children who are in reception, year 1 or year 2 in a state-funded school are offered a **free** healthy school lunch. Children in other school years will also be offered a free school lunch if their parent is receiving any of the welfare benefits listed overleaf.

Registering could raise money for your child's school

Registering for free meals could raise an extra £1,515 for the school, to fund valuable support like extra tuition, additional teaching staff or after school activities. Children that are eligible for this pupil premium funding will benefit directly from the support, and the school is accountable for the difference that is made to individual children.

This additional money is available from central government for every child whose parent is receiving one of the welfare benefits listed in the form. It is therefore important to sign up for free school meals, even if your child is in reception, year 1 or year 2, so that the school receives as much funding as possible, and your child benefits directly from the support available.

How the information in this form will be used

The information you provide in this form will be used by the school to confirm receipt of one of the listed welfare benefits. Once this is confirmed, this helps to decide how much money the school will receive each year.

The information will also be used in relation to children in year 3 or above to decide whether they are eligible for free school meals.

You only need to complete this form once and it will last for the duration of your child's time at this school.
